Sealed bids will be accepted until 8:30 AM on July 10, 2025 at which time the bids will be opened and publicly read at the County Commission's regular meeting. The Scott County Commission reserves the right to reject any and all bids as deemed in the best interest of the County.

III. SPECIFICATIONS / SCOPE OF WORK

- A. Rip Rap Installation
 - a. Supply and place 90# rip rap to prevent future erosion
 - b. Place 90# rip rap blanket on southeast side of bridge
 - c. 75 linear feet from center of bridge of rip rap on the north and south sides of bridge, including underneath the bridge
 - i. 100 linear feet of dirt and rip rap in southeast corner only
 - d. 18 inch minimum thickness of rip rap placement
 - e. 4x4x2 keyway of all rip rap
- B. Footing Repair
 - a. Demolition, repair, and re-pour footing on south side of bridge
 - b. Footing shall be replaced with reinforced concrete as needed for the bridge's use
 - c. Contractor responsible for all formwork, rebar, pouring, finishing, and curing
 - d. County will be responsible for asphalt overlay of road
- C. Erosion Repair
 - a. Repair and stabilization of eroded area on south side of bridge
 - b. Replace any displaced material with 90# minimum rip rap
- D. Ditch Maintenance
 - a. Mop out approximately 600 linear feet of roadside ditch along County Highway 323

E. Additional Information

a. Contractor will need to clear the ditch vegetation and trees on the west side of the bridge

b. Contractor will load the vegetation and tress for the County Highway Department to dispose of material

- F. Optional Add-On
 - a. Provide pricing of the purchase and installation of a filtered fabric overlay to reinforce project effectiveness
