<b>SPECIAL SCHOOL BOND ELECTION PROPOSITION K.I.D.S.</b>

Shall the Scott County Rural Fire Protection District, Missouri, issue general obligation bonds in the amount of One Million Six Hundred Fifty Thousand Dollars (\$1,650,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new firehouse; to complete remodeling and repair improvements to the existing facilities; to acquire and equip a fire truck; to purchase new apparatus and auxiliary equipment to meet current safety standards; and to prepay lease financings?

(If this proposition is approved, the District intends to reduce the general fund levy by \$0.20 per \$100 of assessed valuation in order to offset the estimated \$0.20 per \$100 of assessed valuation increase to the debt service fund levy resulting in the total tax levy to remain unchanged.)
