PROPOSITION K.I.D.S.**

Shall the Board of Education of the Chaffee R-II School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Two Hundred Fifty Thousand Dollars (\$2,250,000) for the purpose of providing funds to repair roofing at the Elementary School; to complete safety/security improvements District-wide, to include, but not limited to, installation of bullet-proof film on windows and door replacement; to upgrade restrooms; to complete exterior tuckpointing; to purchase a new transportation vehicle; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.2500 per one hundred dollars of assessed valuation of real and personal property.
